

Your date of registration is taken w. e. f. **24/11/2022**.

Your registration for the degree of Doctor of Philosophy will be governed strictly under the Chapter XVI of the First Ordinance of Himachal Pradesh University and the UGC Regulations as adopted and amended from time to time, *inter alia*, includes followings:

1. There shall be a minimum residency requirement as prescribed by the UGC/HPU over the entire duration of Ph. D programme to be certified by the Supervisor and the Chairman. This shall be in addition to the six months period of course work required for those candidates who have not done this course work at the M. Phil level.
2. The Ph. D scholar shall submit a six-monthly progress report (through the Supervisor and Chairman) to the Research Degree Committee. The approval of the report by the RDC will be required for the continued registration of the candidate to the Ph. D programme.
3. In service/employed candidate shall be required to submit a 'No Objection Certificate' within a month.
4. Scholar with fellowship will be required to sign attendance register regularly.
5. The Ph. D scholars who have passed their qualifying examination from other Universities but are not registered with this University are required to submit a migration certificate.
6. The candidate is required to deposit half-yearly prescribed fees (if not otherwise exempted) before 20th December 2022, after that, once every six months.

Your registration is subject to the clearance of the further discrepancies, if any, conveyed to you separately.
